#### KEEP OUT OF REACH OF CHILDREN

FIRST AID: If in eyes, flush with water for 15 minutes. If on skin, wash with soap and water. If swallowed, give patient one or two glasses of water and induce vomiting by touching back of throat with a finger or blunt object; repeat until vomit fluid is clear. Do not give anything by mouth to an unconscious person. For all cases of human ingestion, immediately notify a physician or poison control centre. If pet or livestock poisoning is suspected, immediately contact a veterinarian. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN, PETS AND LIVESTOCK. May be harmful or fatal if swallowed or absorbed through the skin. Do not open premeasured place packs. Rubber gloves must be worn when disposing of dead rodents, unconsumed bait and empty containers. Avoid contact with eyes, skin or clothing. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Wash skin thoroughly with soap and water after handling. Wash contaminated clothing, separately from other laundry, with soap and hot water before reuse. KEEP AWAY FROM FEED AND FOODSTUFFS.

**TOXICOLOGICAL INFORMATION:** Vitamin  $K_1$  in the form of intramuscular or subcutaneous injections, or by oral ingestion are suggested remedial treatments for anticoagulant poisoning. The severity of the case measured by establishing prolonged prothrombin times (P.T.) will determine appropriate therapy. Monitoring P.T. will indicate the necessity of repeated treatments.

**DIRECTIONS:** This product is equally effective in dry areas such as indoors and against the outside walls of buildings.

**USE LIMITATIONS**: Bait MUST either be placed in tamper-resistant bait stations or in locations not accessible to children, pets or livestock. DO NOT place bait in areas where there is a possibility of contaminating food or surfaces that come in contact with food.

Place baits in tamper-resistant bait stations along walls, in corners, and in concealed locations where rats feed. Bait

placements should be checked daily to make sure that an uninterrupted supply of bait is available. Maintain an uninterrupted supply of bait for at least 15 days. Continue baiting until all signs of feeding have stopped. Remove any spoiled or contaminated bait promptly.

**RATS:** Place bait bags 6 to 9 metres per placement.

**MICE:** Place bait bags 2 to 3 metres apart. Bait placements should be kept permanently to prevent new infestation.

**STORAGE:** Store in a cool, dry place away from other chemicals and food or feed. Store product not in use, in original container, in a secure location inaccessible to children and non-target animals.

**DISPOSAL:** Dispose of empty container in household garbage. Dispose of unused bait in accordance with local requirements.

**RODENT DISPOSAL:** Dispose of dead rodents in garbage or by burying.
